SUBJECT: Medical Director and School Nurse Role

The Department would like to take this opportunity to remind school districts of the requirements to employ a director of school health services (medical director) their specific role in schools and review the requirements and role of a school nurse.

Student should not be prevented from participating in interscholastic athletics or obtaining working papers because they have not undergone the required health exam. Director of School Health Services

Duties of the Director of School Health Services

Pursuant to Education Law §902, public schools must employ a duly licensed physician or nurse practitioner to perform the duties of the director of school health services to perform and coordinate the provision of health services in public schools. The duties of the medical director include:

Provide a school health services program¹ which includes but is not limited to:

- o Informing parents/guardians, students and teachers of VWXGIHEQtMV¶V condition subject to federal and state confidentiality laws;
- Guide parents, students and teachers in procedures for preventing and correcting defects and diseases;
- Instruct school personnel in procedures to follow in case of accident or illness; and
